About The Workshop

The purpose of the Workshop is for State and EPA Capacity Development and Operator Certification program staff to interactively discuss experiences and challenges in supporting public water systems and share program implementation best practices and successes. This is also an opportunity to interact with partners from other States, EPA Regions, and Technical Assistance Providers to learn about their work and resources for helping drinking water systems build technical, managerial, and financial (TMF) capacity.

How Can I Make the Most of the Workshop?

In light of this year's theme – "50 Years of SDWA: Taking Lessons Learned to Build Towards the Future" – we encourage all attendees to be active participants in sharing your knowledge about implementing capacity-building and operator programs and the approaches you have found successful. We have developed the Workshop agenda with this theme in mind, and most of the sessions will be interactive to foster closer collaboration and engagement. Therefore, all attendees should give some forethought on what program insights they would like to share, or ask, about these session topics:

BIL Breakdown (Activity): Tabletop exercise to better understand the range of funding and technical assistance under BIL. Determine how you would resolve specific case studies utilizing capacity building principles, technical assistance, and Bipartisan Infrastructure Law funding.

Capacity Development (Roundtable Discussion): Discuss new initiatives and resources being developed and/or implemented by the state's capacity development program and hear from attendees who have found creative ways to support water system capacity overcome challenges.

Operator Certification (Roundtable Discussion): Discuss key strategic components that make an effective state program and hear from attendees who are leveraging resources to build up their operator certification and workforce development program.

Succession Planning (Activity): Interactive polling to share best practices for succession planning with attendees on how you would resolve specific case studies.

Assessing TMF Capacity (Roundtable Discussion): Small groups will discuss how States are assessing TMF capacity and how other drinking water programs and resources can be leveraged to assist those systems that lack capacity.

Engagement Catch-All (Activity): Attendees will be split into four groups to exchange effective strategies for engaging different audiences on lead service line inventories and replacements.

Operator Training (Activity): Interactive polling to learn how states are incorporating drinking water "hot topics" such as emerging contaminants, cybersecurity, and emergency response in their training programs.

Transportation & Parking



Flying? The hotel is 15 minutes south of Dane County Regional Airport. The Madison Concourse Hotel offers a complimentary airport shuttle for all overnight guests. From the airport, simply call the hotel when you are ready for pick-up. The shuttle pick-up area is across the street from baggage claim Door 5.

The shuttle runs between 4:30 AM and 11 PM. If you arrive after 11PM, taxis are available at the airport outside Door 7. Rideshare vehicles such as Uber and Lyft pick up to the right of Door 6.



Driving? The Madison Concourse Hotel offers overnight parking to all guests (\$18 per night). The parking entrance is located on Dayton Street, just before the doors to the main lobby. The parking ramp has a clearance of 6 feet. Additional parking is available nearby, at the city's Carroll Street Parking ramp, and can accommodate larger vehicles.

What Should I Bring?

Pack clothes that are professional yet comfortable as attendees will primarily be sitting throughout the workshop. Although the workshop is taking place in August, we recommend bringing a sweater or light jacket in case the conference spaces are chilly. Bring supplies for notetaking and don't forget to bring your business cards! We encourage attendees to stay in touch to continue collaboration and share information with one another.

What is the TA Expo?

The Technical Assistance Exposition (TA Expo) will take place on the first day of the Workshop, August 7th, during a 1-hour block in the morning as well as a 30-minute break in the afternoon. The goal of the TA Expo is to provide an opportunity for Workshop attendees to network with technical assistance providers and learn about their individual experiences and first-hand program knowledge. Therefore, introduce yourself to them. Ask about their services. Connect with them about the capacity-building challenges you encounter in your work. The full agenda includes a conversation starter fun fact about each of the providers as well as a link to their organization's website to learn more.
